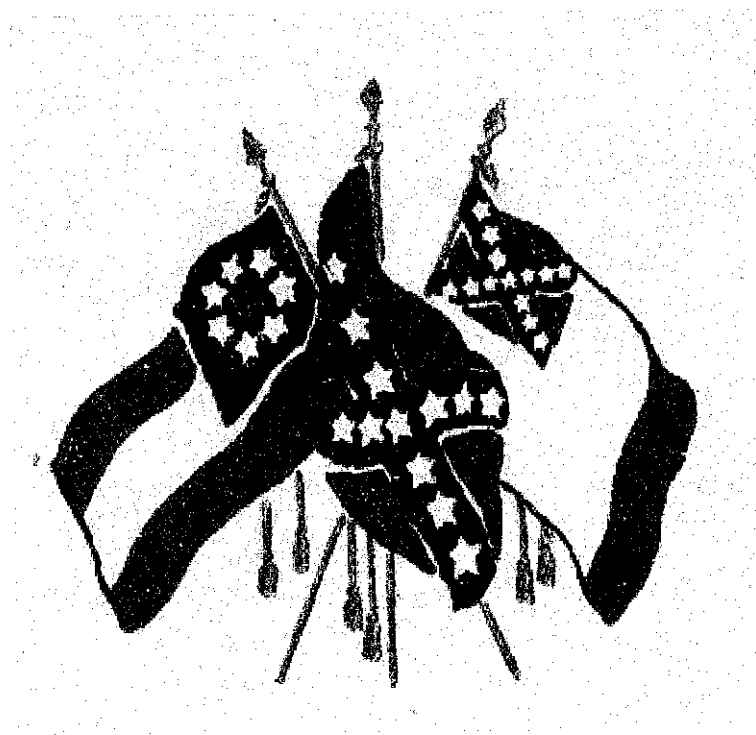

CIVIL WAR FILES (ALABAMA)

PRIMARY SOURCES

Alison, Joseph Dill. Diary, 1861-1865. 1 Item.

Typescript copy of the diary of Joseph Dill Alison entitled, "Old Times in the South." Alison was a member of ~~an unidentified Alabama unit~~, and his diary covers the period from May 1861 – July 1863. Alison was a surgeon during the siege of Vicksburg and gives a good account of his medical duties. *BATTERY C, 2ND AIA. ARTILLERY BATTALION HEBERT'S BRIG.*

Coleman, Isaac B. Letter, 1863. 1 Item.

Photocopy of a letter written by Isaac B. Coleman, a member of Company I, 30th Alabama Infantry. The letter was written on January 24, 1863 from Vicksburg, and describes an outbreak of smallpox in the regiment. *Pub. Alabama Hist. Quarterly IX (Fall 1947) 385-398*

Ferguson, James A. Letters, 1862-1863. 8 Items.

Photocopies of letters written by Private James A. Ferguson, a member of Company F, 42nd Alabama Infantry. The letters were written from June 1862 – May 1863, and document camp life, military operations, and news from home. Included is an application for arrears and pay from Eliza Ferguson after her husband's death dated January 5, 1865.

McGahey, Alexander F. Letters, 1862-1863. 11 Items.

Typescript copies of letters written by Alexander F. McGahey, a member of the 42nd Alabama Infantry. The letters date from August 1862 – August 1863 and contain information about camp life. There is also one letter giving a description of the battle of Corinth. McGahey survived the siege of Vicksburg but died on his way home at Bolton, Mississippi on July 15, 1863.

Payton, S. B. Letter, 1863. 1 Item.

Photocopy of a letter written by S. B. Payton, a member of an unidentified Alabama unit. The letter is dated March 8, 1863 from Warrenton, Mississippi and gives a brief description of camp life and asks for news from home.

Pettus, Edmund Winston. Letter, 1903. 1 Item.

Typescript copy of a letter to Commissioner William T. Rigby of the Vicksburg National Military Park concerning Pettus' participation in burying General Isham W. Garrott during the siege of Vicksburg. Pettus was Lieutenant Colonel of the 20th Alabama Infantry during the siege and was later promoted to Brigadier General in the Confederate Army.

Roebuck, Robert W. Pass, 1862. 1 Item.

Pass given to Lieutenant Robert W. Roebuck, a member of Company G, 16th Alabama Infantry. The pass is dated June 9, 1862 at Tupelo and grants Roebuck a 24-hour furlough to go retrieve some items he left at Verona, Mississippi.

Ryan, T. C. Memoir, ????. 1 Item.

Memoir, "*Experiences of a Soldier in the Civil War*," by T. C. Ryan, a member of Company H, 27th Alabama Infantry. Ryan served with the 27th until the fall of Vicksburg, then in early 1864 he transferred to the 12th Alabama Infantry.

Smith, Daniel P. First Alabama Infantry Regimental History, 1885. 1 Item.

Regimental History written by Daniel P. Smith entitled, Company K First Alabama Regiment of Three Years in the Confederate Service. Located in the white cabinet.

Willett, Elbert D. Diary, 1862-1865. 1 Item.

Photocopy of the diary of Elbert D. Willett, Captain of Company B, "Pickens Planters," 40th Alabama Infantry. The diary was published in 1963 by Colonial Press under the title History of Company B. Located in the Chickasaw Bayou subject file.

CIVIL WAR FILES (ARKANSAS) PRIMARY SOURCES

Hayley, F. M. Letters, 1863. 5 Items. - ?

Photocopies of letters written by F. M. Hayley, a member of the 25th Arkansas Infantry. The letters cover the period from February – September 1863. Included in the file is a photograph of Hayley taken early in the war.

Kidd, James Tillman. Memoir, ????. 1 Item.

Memoir written by James T. Kidd, a member of Company A, 20th Arkansas Infantry. The memoir covers the period from March 18, 1862 – May 28th, 1865, and goes into detail about the siege of Vicksburg.

Lehan, C. Papers, 1864. 3 Items.

Papers relating to Lieutenant C. Lehan of Company A, 5th & 13th Arkansas Infantry. The first document is an order dated November 23, 1863 confirming his election to Lieutenant. The other two papers deal with his being absent without leave and are dated December 6, 1864.

Wheeler, J. S. Letter, 1863. 1 Item.

Photocopy of a letter written by J. S. Wheeler, a member of McNally's Arkansas Battery to his sister Mrs. Sheppard in Monroe, Perry County, Mississippi. The letter was written on April 28, 1863 from Deer Creek in Issaquena County and describes a scouting expedition along Deer Creek.

CIVIL WAR FILES (GEORGIA)

PRIMARY SOURCES

Banner, Matthew Rauley. Letters, 1862-1865. 1 Item.

Bound typescript copies of letters written by Matthew R. Banner, a member of Companies A & I, 39th Georgia Infantry. The letters are very detailed and cover the entire war, with a particular emphasis on the Vicksburg campaign. Located in a black binder in Civil War File #3.

Bogle, Joseph. Memoir, 1911. 1 Item.

Photocopy of the memoir of Joseph Bogle entitled "*Some Recollections of the 'Civil War,'*" first published in the Dalton, Georgia Daily Argus in 1911. Bogle served as a Private in Company I, 40th Georgia Infantry and he details the history of the regiment from 1862 – 1865, including their service at Vicksburg during the siege.

Burgess, John T. Letters, 1863. 2 Items.

Photocopies of two letters written by John T. Burgess, a member of Company B, 29th Georgia Infantry during the Vicksburg campaign. The first letter is dated May 14, 1863 from "*Headquarters.*" The second is dated June 18, 1863 from "*Headquarter near Canton.*"

Cantrell, Oscar. Regimental History, ??????. 1 Item.

Photocopy of the book Sketches of the First Regiment Georgia Volunteers, by Oscar Cantrell, a member of the unit. The copy is incomplete, but does detail the service of the regiment in Virginia. Included with the copy is a complete history of the 58th Georgia Infantry which participated in the Vicksburg campaign. 56th

Fowler, William A. Letters, 1863. 3 Items.

Photocopies of letters written by William A. Fowler, a member of Company B, 43rd Georgia Infantry. All three letters were written in Vicksburg and are dated March 8, March 10, and April 17, 1863.

Hammack, D. D. Letters, 1862-1863. 2 Items.

Photocopy of a letter written by D. D. Hammack, a member of Company H, 51st Georgia Infantry. The letter is dated April 8, 1862 and gives news from camp. The file also contains a copy of a letter dated January 9, 1863 informing the friends of Hammack that he died of Typhoid Fever on January 8, 1863.

Johnson, George B. Letter, 1863. 1 Item.

Photocopy of a letter written by 1st Sergeant George B. Johnson of Company D, 34th Georgia Infantry. The letter is dated March 24, 1863 from Vicksburg and relates the recent war news from the area.

Murphy, Matthias. Letter, 1863. 1 Item.

Photocopy of a letter written by Matthias Murphy, a member of the 40th Georgia Infantry.
The letter was written from Vicksburg on January 18, 1863.

CIVIL WAR FILES (KENTUCKY, C.S.A.) PRIMARY SOURCES

Hawes, Maria Southgate. Memoir, ????. 1 Item.

Typescript copy of the memoir of Maria S. Hawes, wife of James Morrison Hawes of Bourbon County, Kentucky. James was an officer in the pre-war U. S. Army, and Maria describes her life as an army wife. When the war started, James resigned his commission and organized the 2nd Kentucky Infantry. The memoir covers the period from 1836 – 1866.

Reid, S. C. John Hunt Morgan Book, 1864. 1 Item.

Book by S. C. Reid entitled, A Full Account of the Capture and Wonderful Escape of Gen. John H. Morgan with Captain T. Henry Hines. Published in Atlanta, Georgia, by Intelligencer Steam Power Presses, 1864.

Taylor, H. M. Letter, 1926. 1 Item.

Letter written by H. M. Taylor, a member of John Hunt Morgan's command, to V. Blaine Russell in Vicksburg, describing activities of the Morgan's Men Association.

CIVIL WAR FILES (LOUISIANA)

PRIMARY SOURCES

Baucum, Shelby. Papers, 1862-1863. 2 Items.

Officer's commission and parole from Vicksburg belonging to Shelby Baucum, Captain of Company E, 31st Louisiana Infantry. The parole is on display in the Confederate Room.

Bond, John. Diary, 1862-1863. 2 Items.

Copy of the diary of John Bond, a member of Company C, 27th Louisiana Infantry. The diary covers the period from August 18, 1862 – April 28, 1863. The diary was published in the genealogy magazine Mississippi River Routes, Winter 1997 and Spring 1998 issues.

Dunn, Edward J. Memoir, ????. 1 Item.

Memoir of Civil War service written by Edward J. Dunn, a member of Company B, 23rd Louisiana Infantry. The memoir is entitled "*The Life of Edward J. Dunn*," and covers the period from October 8, 1861 – March 3, 1865.

Feret, Miss. Letter, 1863. 1 Item.

Typescript copy of a letter sent to Miss Feret informing her that her brother Jules had died. Jules Feret was a member of the 2nd Company Washington Artillery and was mortally wounded at Gettysburg. Located in the Millikens Bend subject file.

Fischel, Leon. Photograph, 186? 1 Item.

Copy of a wartime photograph of Leon Fischel, a member of the Tensas Cavalry, Company A, 15th Battalion Louisiana Cavalry.

Fuller - John - Co K - 31st LA Infantry - Diary

Hall, W. T. Letter, 1861. 1 Item.

Photocopy of a letter written by W. T. Hall, a Lieutenant in Company B, 3rd Louisiana Infantry. The letter is dated November 11, 1861 from Camp McCulloch, Arkansas and gives considerable detail about the recent movements of the regiment.

Hardesty, J. T. Letter, 1863. 1 Item.

Photocopy of a letter written by J. T. Hardesty, a member of Company B, 27th Louisiana Infantry, to his sister on July 9, 1863.

Hawthorn, R. J. Substitute Contract, 1862. 1 Item.

Substitute contract between R. J. Hawthorn and Matthias Kelly, both residents of Franklin Parish, Louisiana. On September 25, 1862 Hawthorn agreed to pay 1,500 to serve as a substitute for him in the Confederate Army.

Mitchie, William. Photograph, 1862 1 Item.

Copy of the photograph of ~~William~~ Mitchie, Captain of Company B, 15th Louisiana Infantry, Army of Northern Virginia.

Mumford, William Taylor. Diary, 1862-1863. 1 Item.

Typescript copy of the diary of William T. Mumford, a member of Company B, 1st Louisiana Heavy Artillery. The diary covers the period from April 18, 1862 – December 31, 1863.

Sanders, Jared Young. Diary, 1862-1863. 1 Item.

Typescript copy of the diary of Jared Y. Sanders, a member of Company B, 26th Louisiana Infantry. The diary was published in the Louisiana Genealogical Register, Volume 17, Number 3, (September 1970). The diary covers the period from September 25, 1862 – July 11, 1863.

Trahan, Raymond. Letter, 1863. 1 Item.

Photocopy of a letter written by Raymond Trahan, a member of the 26th Louisiana Infantry. The letter is dated January 30, 1863 and describes the fighting at the battle of Chickasaw Bayou. The original manuscript was written in French, and a translation into English is included.

Tunnard, William H. Regimental History, 1866. 1 Item.

Regimental history of the 3rd Louisiana Infantry entitled, A Southern Record by William H. Tunnard, a member of Company K. Privately printed for the author, 1866.

CIVIL WAR FILES (MISSISSIPPI)

PRIMARY SOURCES

Adams, Walter. Letters, 1861. 8 Items.

Letters written by Walter Adams, a member of Company A, 21st Mississippi Infantry. These letters were written between February 16, 1861 and September 25, 1861 and describe the company's travel from Mississippi to Virginia. The collection also includes a CDV of Adams in uniform. Original letters are located in the black book.

Adams, Wirt. Receipt, 1861. 1 Item.

Receipt from the banking house of General Wirt Adams dated October 26, 1861. The receipt acknowledges the deposit of 550.00 by General Church.

Archer, Richard T. Letter, 1862. 1 Item.

Photocopy of a letter from Richard T. Archer to John Hampden Randolph, owner of Anchuca Plantation in Warren County, Mississippi. The letter is dated March 25, 1862 and mentions Randolph's sons who were fighting for the Confederacy.

Bingham, D. C. M. Memoir, ????. 1 Item.

Typescript copy of the memoir "*Personal Reminiscences of the Civil War*," by D. C. M. Bingham, a member of the 11th Mississippi Cavalry. The memoir details Bingham's participation in the battle of Selma, Alabama.

Blackwell, Joseph B. Letters, 1863. 1 Item.

Six letters written by Joseph B. Blackwell of Raleigh, Mississippi who served in the Quartermaster's Department of the Confederate Army and was stationed at Petersburg, Virginia. Four of the letters are dated between June 16 – August 4, 1863. Two of the letters are undated, and the file includes a copy of Blackwell's obituary.

Boggan, Young Walter. Letters, 1861-1862. 1 Item.

Typescript copies of letters written by Young Walter Boggan, a member of Company G, 8th Mississippi Infantry. The letters date from November 16, 1861 – June 18, 1862, and were written from various camps near Pensacola, Florida.

Bolls, James. Photograph, 186? 2 Items.

Copy of a photograph of James Bolls, a member of Company C, 16th Mississippi Infantry. Included is a copy of the obituary for Bolls from the Commercial Appeal in 1919. Located in the Bolls genealogy file.

Bounds, Benjamin H. Memoir, ????. 1 Item.

Photocopy of the memoir of Benjamin H. Bounds entitled, Ben H. Bounds 1840-1911 Methodist Minister and Prominent Mason. Bounds was a member of Company F, 4th Mississippi Infantry.

Bowie, Aquila. Memoir, ????. 1 Item.

History of the Bowie family of Vicksburg, describing life for them during the siege of Vicksburg. The work is particularly concerned with the courtship of Elizabeth Bowie by two Confederate soldiers.

Bradford's Scouts. Roster, ????. 1 Item.

Post-war roster of Bradford's Scouts, a unit from Warren County, Mississippi. The roster lists date & place of enlistment, and current residence at the time the roster was compiled.

Champion, Sidney S. Letters, 1862-1865. 76 Items.

Typescript copies of letters written by Sidney S. Champion, a member of Company I, 28th Mississippi Cavalry, to his wife Matilda. The letters date between May 24, 1863 – April 22, 1865. Included in this file are copies of Matilda's letters to Sidney from March 29, 1863 – October 25, 1864. Sidney Champion rose through the ranks from Sergeant to Captain of Company I, and eventually to Lieutenant Colonel of the regiment.

Clark, D. J. Provost Pass, 1864. 1 Item.

Union Provost Marshal's pass for D. J. Clark, allowing him to bring nine bales of cotton into Vicksburg to sell. The pass is dated January 25, 1864 and is located in the black book.

Cook, Henry F. Papers, 1863-1865.

Papers of Henry F. Cook, a member of the Confederate Commissary Department assigned to Southwest Mississippi. Major Cook was a resident of Warren County, Mississippi, and he traveled throughout the Southwest portion of the state obtaining supplies for the Confederacy.

Cowan, James J. Papers, 1863-1864. 2 Items.

Photocopy of a letter from James J. Cowan, Captain of Company G, 1st Mississippi Light Artillery, to his wife Irene. The letter is dated April 11, 1864 and describes the battery's movements in and around the town of Montevilla, Alabama. Included is a copy of the pass given by the U. S. Army allowing Captain Cowan to leave Vicksburg dated August 20, 1863.

Crist, Robert H. Letter, 1860. 1 Item.

Photocopy of a letter written by Robert H. Crist, a carpenter from Cedar County Iowa who worked in Natchez in 1860. The letter is dated April 1, 1860 and describes to his father what life is like in the South, giving Crist's views on slavery and white Southern society. Crist served in the 21st Indiana Infantry, later designated the 1st Indiana Heavy Artillery.

Curtiss, Mrs. E. D. Pass, 1864. 1 Item.

Pass granted to Mrs. E. D. Curtiss on March 12, 1864 by the Union Provost Marshal's office in Vicksburg. This pass allowed her to leave Vicksburg with supplies for her residence in Copiah County. Located in the black book.

Davis, Jefferson F. Papers, 1845-1904. 23 Items.

Correspondence and papers of Jefferson Davis, Warren County Planter and President of the Confederate States of America. Included are items from various members of the Davis Family. Items are located in the Jefferson Davis Folder in Civil War Cabinet #4.

Disabled Soldiers and Widow's List. 1867. 1 Item.

Photocopy of a list of disabled Confederate soldiers and widows in Warren County, Mississippi dated January 8, 1867. The list is taken from the Warren County Supervisors Minute Book, 1853-1857. The original is on file in the new Warren County Courthouse.

Dixon, Mumford Harris. Diary, 1864. 1 Item.

Typescript copy of the diary of Mumford Harris Dixon of Vicksburg. Dixon was Captain of Company G, 3rd Confederate Infantry Regiment. The diary begins May 7, 1864 and details the Atlanta campaign and the Battle of Franklin. Dixon was captured at Franklin, and the diary ends December 2, 1864 as he is being marched to a Northern prison camp.

Downing, Henry C. Papers, 1865. 2 Items.

Papers of Henry C. Downing, a resident of Vicksburg and a member of Company H, 48th Mississippi Infantry. Included are a pass for Downing to travel from New Orleans to Vicksburg dated May 25, 1865 and the Oath of Amnesty taken by Downing at Vicksburg dated July 5, 1865. Originals are in the black book.

Duncan, Edmund R. Newspaper Article, 1862. 1 Item.

Photocopy of an article from an unidentified newspaper about the bravery of Edmund R. Duncan at the battle of Chickasaw Bayou. Duncan was a member of Company E, 1st Mississippi Light Artillery. Located in the Chickasaw Bayou research file.

Ellis, J. N. & M. H. Diary, 1863. 1 Item.

Photocopy of a diary written by J. N. and M. H. Ellis, brothers in Company I, 43rd Mississippi Infantry. The diary covers the siege of Vicksburg from May 17, 1863 – July 4, 1863.

Faulk, William Larkin. Diary, 1863. 1 Item.

Typescript copy of the diary of William Larkin Faulk, Captain of Company B, 38th Mississippi Infantry during the siege of Vicksburg. The diary covers the period from May 18, 1863 – July 4, 1863 and goes into great detail about life during the siege. Included are copies of three letters written after the war by Faulk to Captain William Rigby, Commissioner of the Vicksburg National Military Park, describing the fighting done by the 38th at Vicksburg. The letters are dated April 17, April 23, and April 30, 1903.

Ferguson, George Washington. Daguerreotype, ????. 1 Item.

Pre-war daguerreotype of George Washington Ferguson, a resident of Warren County, Mississippi. During the Civil War Ferguson served as a member of Company I, 28th Mississippi Cavalry.

First Mississippi Light Artillery. Reunion Materials, 1915. 2 Items.

Copy of the minutes for the reunion of Company A, 1st Mississippi Light Artillery, held June 3, 1915 at the courthouse in Jackson. The file also includes a reunion photograph of the survivors of the company.

Fort Hill Photograph, ????. 1 Item. refer to *Whistling Dick* in "Research"
Post-Civil War photograph of Fort Hill taken by an unidentified Confederate surgeon from Missouri. The photo is labeled on the back, "*Fort Hill, Whistling Dick, Vicksburg.*"

Forty-Eighth Mississippi Infantry. Roster, ????. 1 Item.

Roster of the companies of the 48th Mississippi Infantry, compiled by Frank H. Foote. Foote was a member of Company F, and wrote the list some years after the war.

Foster, William Lovelace. Letter, 1863. 1 Item.

Letter written by William Lovelace Foster, Chaplain of the 35th Mississippi Infantry. This letter was published in book form under the title Vicksburg: Southern City Under Siege by the Historic New Orleans Collection, New Orleans, Louisiana (1980). Located in the white cabinet.

Frierson, James & Charles. Letters, 1862. 1 Item.

Typescript copies of letters written by James & Charles Frierson, members of Company F, 15th Mississippi Infantry. Both letters concern the regiments participation in the Battle of Mill Springs, Kentucky on January 19, 1862.

Fulghum, James M. Letter, 1862. 1 Item.

Letter written by James M. Fulghum, Captain of Company K, 36th Mississippi Infantry. The letter is dated September 24, 1862 and gives an account of the battle of Iuka which took place on September 19, 1862.

Goodrum, James. Provost Pass, 1864. 1 Item.

Union Provost Marshal's pass dated January 12, 1864 allowing James Goodrum of Warren County to bring 22 bales of cotton into Vicksburg to sell. Located in the black book.

Goodrum, Mrs. S. Protection Order, 1863. 1 Item.

Union army protection order granted to Mrs. S. Goodrum in Vicksburg dated August 24, 1863.

Gordon, James. Speech, 1910. 1 Item.

A copy of the farewell speech of Mississippi Senator James Gordon, given on February 24, 1910. The speech includes reminiscences about Gordon's service in the 2nd Mississippi Cavalry.

Grammer, Albert. Diary, 1862-1864. 1 Item.

Typescript copy of the diary of Albert Grammer, a member of the Warren Light Artillery (Swett's Battery). The battery served in the Army of Tennessee; and Grammer records his service with the unit from early 1862 until April 15, 1864. See Cotton column C-87 for biographical information on Albert Grammer.

Haddon, Columbus Bradshaw. Memoir, 1922. 1 Item.

Copy of the memoir of Columbus B. Haddon, a Sergeant in Company H, 20th Mississippi Infantry. Located in the genealogy files.

Hanes, Thomas Jefferson. Letters, 1861-1863. 3 Items.

Letters from Thomas Jefferson Hanes, a Lieutenant in Company A, 21st Mississippi Infantry, later transferred to Cowan's Mississippi Battery. The first letter is dated June 6, 1861 and describes the trip of Company A to Virginia. The second letter is dated March 25, 1863 telling his mother what to do when the Yankees invade. Included is a newspaper account of Hanes' wounding at the battle of Nashville. Located in the Black Book. Note: There is a post-war photo of Hanes on display in the Confederate Room.

Harris, Nathaniel Harrison. Diary, ????. 1 Item.

Photocopy of the diary of Nathaniel H. Harris, Captain of Company C, "Warren Rifles," 19th Mississippi Infantry. He was promoted to Major, then Colonel of the 19th Mississippi, then went on to command a brigade made up of the 12th, 16th, 19th, and 48th Mississippi Infantry Regiments. The diary gives a brief summary of his life, than an account of his service from 1861-1865.

Harrison, Ida Withers. Book, ????. 1 Item.

Photocopy of one chapter of the book Memoirs of William Temple Withers by his daughter Ida Withers Harrison. The chapter copied concerns the Vicksburg campaign and has entries from Withers diary. He commanded the artillery during the siege of Vicksburg.

Henry, William Thomas. Letters, 1863-1864. 8 Items.

Eight letters written by William Thomas Henry, a member of Harvey's Scouts. The letters are dated from March 21, 1863 – 13 November 1864. Located in the black book. Note: There is a pre-war tintype of Henry and a parole issued to him on display in the Confederate Room.

Herring, Isaac E. Letters, 1861-1865. 36 Items.

Typescript copies of letters written by Isaac E. Herring, a member of Company G, 1st Mississippi Light Artillery. The letters cover the period from 1861 – 1865 and detail Herring's war experiences.

Hicks, William Anderson. Letter, 1862. 1 Item.

Letter from Lieutenant William Anderson Hicks, an officer serving on the C.S.S. *Capitol*. Hicks was a resident of Vicksburg and he wrote to his parents on April 20, 1862 from Memphis describing his assignment to the *Capitol*.

Howe, R. D. Conscription Examination, 1864. 1 Item.

Conscription examination of R. D. Howe done by the Bureau of Conscription at Enterprise, Mississippi. Howe was ordered into the Confederate Quartermaster Corps as a clerk because of his bad eyesight.

Hughes, Felix. Letter, 1862. 3 Items.

Photocopy of a letter from Felix Hughes to Governor John J. Pettus dated May 13, 1862. Hughes was Captain of Company C, 22nd Mississippi Infantry, and at the time was acting Colonel of the regiment. He wrote to the governor requesting more men be sent to the regiment to make good their losses from battle and disease. Also included is a copy of Hughes' service record and his last will and testament. Note: A portrait of Captain Hughes in uniform is on display in the Confederate Room.

Jermyn, James. Diary, 1861-1864. 1 Item.

Typescript copy of the diary of James Jermyn, a member of Company E, 20th Mississippi Infantry. The diary covers the period from July 12, 1861 – August 8, 1864. The diary has very brief entries and has little detail. Located in the Red Bone Church File.

Jett, Samuel E. Letters, 1864. 4 Items.

Three original letters written by Private Samuel E. Jett while he was a prisoner of war at Camp Chase, Ohio in 1864. Jett was a member of Company G, 1st Mississippi Light Artillery. There is also a copy of a letter sent to Jett from his sister Laura.

Johnson, William H. Order, 1862. 1 Item.

Order from Captain William H. Johnson, Company I, 28th Mississippi Cavalry, to Captain James Goodrum, ordering him to hold his company in readiness to assist in repelling the enemy if they should attempt to ascend the Mississippi River. The order is dated May 24, 1862 from on board the steamer *Vicksburg*.

Kellar, William Tell. Photograph, ??????. 1 Item.

Post-war photograph of William T. Kellar, a member of Company A, 16th Mississippi Infantry. Written on the back of the photo is the inscription, "*Wm. Tell Kellar Co. A 16th Miss Hoods Brigade Stonewall Jackson Army CSA.*" Located in photograph box 6.

Kern, John T. Diary & Letter, 1864. 2 Items.

Diary of John T. Kern, a member of Company K, 45th Mississippi Infantry. The diary begins January 1, 1864 and concludes August 20, 1864. The file also includes a typescript copy of a letter written by Kern to his mother on April 2, 1864.

Lanier, Eliza Ann. Memoir, 1911. 1 Item.

Typescript copy of the memoir of Eliza Ann Lanier entitled, "*Recollections of Eliza Ann Lanier.*" Lanier was a resident of Warren County and she wrote her memoir in 1911 when she was 84 years old. She describes life in Warren County under Federal rule after the siege of Vicksburg.

Lee, Stephen D. Letters, 1897-1908. 1 Item.

Letter from General Stephen D. Lee to Mrs. Charles Wright dated February 10, 1897 accepting a membership in the Confederate Cemetery Memorial Association. Letter is in the black book.

Leon, Mrs. Arthur. Letter, ????. 1 Item.

Photocopy of a letter by Mrs. Arthur Leon relating some of the war stories told to her about her Uncles James Jr. and Pat Bolls. James served in the 16th Mississippi Infantry, and Pat served in the 1st Mississippi Light Artillery. This letter is in the William L. Foster file.

Lightsey, Joseph Benjamin. Memoir, 1908. 1 Item.

Copy of the memoir of Joseph B. Lightsey, a member of Company H, 37th Mississippi Infantry. This memoir was first published as a series of articles in the Jasper County Review in 1908.

Livingston, Martin. Diary, 1863-1865. 1 Item.

Typescript copy of the diary of Martin Livingston, a member of Company F, 35th Mississippi Infantry. Livingston was from Winston County, and his diary covers the period from June 15, 1863 – January 1, 1865.

Typescript copy of a letter written by Warren County resident Leila Lum about the use of her family home as headquarters by Confederate General John H. Forney. Located in the files under John H. Forney Historical Society.

Photograph of Ralston and William McCardle in their Confederate uniforms. They were Vicksburg residents and both served in Company K, 12th Mississippi Infantry. A note with the photograph says it was made from the original in December, 1926 in Vicksburg by Mrs. Mary Waggenor, daughter of Ralston McCardle.

McQuade, John. Newspaper Article, ????. 1 Item.

Typescript copy of a letter written to the Vicksburg Herald by John McQuade, giving details about the death of General Patrick Cleburne at the battle of Franklin, Tennessee. McQuade was a Vicksburg resident and had been a member of Cowan's Mississippi Battery.

Mecklin, A. H. Newspaper Article, 1921. 1 Item.

Typescript copy of an article written by A. H. Mecklin, a member of Company H, 15th Mississippi Infantry. Published in the Memphis Commercial Appeal on May 8, 1921, it describes Mecklin's participation in the battle of Shiloh, Tennessee.

Miller, Dora Richards. Diary, ????. 1 Item.

Typescript copy of the diary of Dora R. Miller entitled, "*War Diary of a Union Woman in the South.*" In the diary she details her experiences as a Union woman living in Vicksburg during the siege of the city.

Mississippi College Rifles. Muster Roll, 1861. 1 Item.

Photocopy of a muster roll for Company E, 18th Mississippi Infantry, the "*Mississippi College Rifles.*" The roll is dated April 20, 1861.

Moore, W. G. Letter, 186?. 1 Item.

Letter written by Private W. G. Moore to his wife Emma dated February 14 from Columbus, Mississippi. Moore served in Company K, 45th Mississippi Infantry.

Morally, Parker. Pass, 1861. 1 Item.

Photocopy of a pass issued to Parker Morally, Sergeant in Company I, 15th Mississippi Infantry. The pass gives him permission to travel home to Choctaw County from June 10 – June 25, 1861.

Murphree, Thomas M. Biography, ????. 1 Item.

Photocopy of a biography written by Dennis Murphree, son of Thomas M. Murphree, a member of Company F, 4th Mississippi Infantry. The biography covers the service of Thomas Murphree during the war.

Nash, John Calvin. Letter, 1864. 1 Item.

Photocopy of a letter written by Sergeant John C. Nash, a member of Company K, 40th Mississippi Infantry. The letter was written June 23, 1864 from Marietta, Georgia. Located in the Nimrod N. Nash file.

Nash, Nimrod Newton. Letters, 1861 – 1863. 1 Item.

Photocopies of letters written by Nimrod N. Nash, a member of Company I, 13th Mississippi Infantry. The letters cover the period from May 16, 1861 – June 28, 1863. Typescript copy of the diary of Lafayette Rogan, a member of Company B, 34th Mississippi Infantry. Rogan enlisted at Ripley, Mississippi and was captured at Lookout Mountain. The diary was written while Rogan was imprisoned at Rock Island, Illinois and covers the period from January 1, 1864 - December 31, 1864.

Ryan, John G. Letter, 1865. 1 Item.

Photocopy of a letter written by John G. Ryan, Captain of Company B, 12th Mississippi Cavalry. The letter is dated November 7, 1865 and is written to Governor Benjamin Humphreys. Stephens, Samuel. Letters, 1862-1863. 4 Items.

Four letters written by Samuel Stephens to his wife in Natchez as he traveled from town to town with tools for the Confederate government. Three letters are written from Columbus, Mississippi and are dated June 25, October 15, and November 9, 1862. The last letter was written from Selma, Alabama and is dated February 20, 1863.

Thornhill, Eleazer W. Memoir, ????. 1 Item.

Photocopy of a memoir written by Eleazer W. Thornhill, a member of Company E, 38th Mississippi Infantry. The memoir covers the period from 1862 -1863, and goes into detail about the siege of Vicksburg. Thornhill was badly wounded during the siege and was never able to return to his regiment.

PRIMARY SOURCES

Bogy, Joseph V. Letter, ????. 1 Item.

Letter written after the war by Joseph V. Bogy detailing his service with the 2nd Missouri Light Artillery. Bogy was from Jefferson County, Arkansas, and also served in McNally's Arkansas Battery. He mentions in his letter the battles of Pea Ridge, Corinth, and Vicksburg.

Bradley, George. Memoir, 1896. 1 Item.

Typescript copy of a memoir written by George Bradley, a member of Company F, 5th Missouri Infantry. The memoir details his service with the regiment from 1861 – 1865.

Ewing, George S. Letter, 1865. 1 Item.

Photocopy of a letter written by George S. Ewing, a member of Company C, 3rd Missouri Infantry. The letter is dated May 10, 1865, from Jackson, Mississippi. Ewing talks in his letter about the Confederate surrender and his plans to return home.

Fisher, Theodore D. Diary, 1863. 1 Item.

Typescript copy of the diary of Theodore D. Fisher, a member of Company F, 2nd Missouri Infantry. The diary covers the period from May 12, 1863 – July 25, 1863, and relates his experiences during the siege of Vicksburg.

Second Missouri Cavalry. Letters, 1864. 3 Items.

Typescript copies of three letters dealing with the presentation of a flag to the 2nd Missouri Cavalry by Annie Fort and Pattie Askew, two young ladies from Columbus, Mississippi.

Crisp, A. J. Letter, 1865. 1 Item.

Letter from A. J. Crisp, a Lieutenant in Company B, 4th Tennessee Infantry to his parents, dated January 1, 1865. Crisp was a prisoner on Johnson's Island and he talks in his letter of good times back home. Located in the black book.

Cunningham, Preston D. Letters, 1862. 4 Items.

Three letters written by Colonel Preston D. Cunningham, commander of the 28th Tennessee Infantry. The letters are dated August 25, 1862, September 1, 1862, and October 14, 1862. The first two letters were written from Camp Sulphur Springs, Jackson, Mississippi, and the third from Knoxville, Tennessee. Also included with the collection is a pre-war ambrotype of Colonel Cunningham. Located in the black book.

Giddens, Benjamin Crownover. Letters, 1862-1863. 8 Items.

Photocopies of letters written by Benjamin C. Giddens, a member of Company G, 3rd Tennessee Infantry. The first letter is written in early 1862, when the regiment was at Wyettsville, Virginia. The remaining letters are written between January 1863 and April 1863 when the regiment was stationed in Vicksburg. Many of his letters talk about the Sexton family of Vicksburg who took Giddens in while he was sick and nursed him back to health.

Hoggatt, Nathaniel. Photograph, 1861. 1 Item.

Copy of a photograph in uniform of Lieutenant Nathaniel Hoggatt, a member of Company C, "*Gibb's Confederate Guards*," 21st Tennessee Infantry. Located in the genealogy files under Hoggatt. Note: This company was raised in Vicksburg.

Hubbard, John Milton. Regimental History, 1911. 1 Item.

Regimental history of the 7th Tennessee Cavalry, written by John M. Hubbard of Company E. The book is entitled Notes of a Private, and was published in 1911. Located in the white cabinet.

Morton, William. Letters, 1863. 2 Items.

Photocopies of two letters written by William Morton, a member of Company G, 79th Tennessee Infantry. The letters are dated March 7 & 10, 1863, and talk about camp life and the military situation around Vicksburg.

Putnam, Samuel. Parole, 1864. 1 Item.

Parole signed by Samuel Putnam of Knox County, Tennessee, at Fort Warren in November 1864. Located in the black book.

Savage, John H. Photograph, ????. 1 Item.

Photograph taken from an unidentified book of John H. Savage in his Mexican War uniform. Savage later served as Colonel of the 16th Tennessee Infantry.

Smoot, N. C. Letter, 1862. 1 Item.

Typescript letter written at Memphis on November 28, 1862 from N. C. Smoot to his wife telling her about being sent to Vicksburg for exchange. Smoot was arrested in Hampshire County for suspected disloyalty to the United States and confined at Camp Chase before being exchanged at Vicksburg. For more information see Cotton column C 80.

Wilson, R. A. Letter, 1863. 1 Item.

Photocopy of a letter written by Reverend R. A. Wilson to his wife in Pulaski, Tennessee. Wilson was Chaplain of an unidentified Tennessee regiment, and wrote from Vicksburg on February 21, 1863 about the unsuccessful Union attempts to take the city.

Anderson, E. M. Letters, 1862-1864. 2 Items.

Photocopies of two letters written by E. M. Anderson, a Sergeant in Company D, 3rd Texas Cavalry, to his wife Jane in Greenville Texas. The first letter is dated September 24, 1862 and describes the battle of Iuka. The second letter is dated April 19, 1864 from Lauderdale Springs, Mississippi, and talks about moving into North Mississippi to support General Nathan B. Forrest.

Caylor, F. M. Letters, 1862-1863. 7 Items.

Letters written by F. M. Caylor, a member of Company F, Waul's Texas Cavalry. The letters are dated between July 19 – October 5, 1863, and describe the movements of the regiment through Mississippi before and after the siege of Vicksburg.

Frazier, Alex. Diary, 1862-1863. 2 Items.

Diary written by Alex Frazier, a member of Company E, 2nd Texas Infantry. Frazier gives an account of his service during the Vicksburg campaign and goes into detail about the siege. The diary covers the period from May 12, 1863 – July 10, 1863. Included in the file is a pre-war diary describing Frazier's trip from Pennsylvania to Texas. For more information see Cotton Column A 81.

Lenert, Albert C. Diary, 1863. 1 Item.

Typescript copy of the diary of Albert C. Lenert, a member of Company A, Waul's Texas Legion (Captain Timmons Company, Nichols Regiment.) The diary has entries from May 17, 1863 – June 10, 1863, and goes into considerable detail about the regiments service during the siege.

Simons, Maurice Kavanaugh. Diary, 1862-1863. 1 Item. 2ND TEXAS INF

Photocopy of a diary kept by Major Maurice K. Simons who served in the Confederate Commissary Department. Simons was from Texarkana, Texas, and his diary covers the period from September 29, 1862 – September 25, 1863.

Ware, Theophilus. Letters, 1862-1863. 7 Items.

Photocopies of letters written by Theophilus Ware, a member of the 27th Texas Cavalry. The letters are written by Ware's mother in Saint Augustine, Texas, and date between November 14, 1862 – September 8, 1864.

Waul, Thomas N. Letter, 1862. 1 Item.

Photocopy of a letter written by General Waul to his wife describing the training of Waul's Texas Legion. The letter is dated June 16, 1862, from Camp Waul, Texas.

Two booklets – Texas at Vicksburg, which lists all of the units from the state that served at Vicksburg, and Dedication of the Texas Monument at Vicksburg.

Pocket diary of William Clary, a member of Company G, 28th Virginia Infantry. The 28th fought in the east, and the diary covers the period from July 17, 1861 – May 7, 1862. A typescript copy of the diary is included in the file.

Flowerree, Charles Conway. Ambrotype, 186?. 2 Items.

Ambrotype in uniform of Charles Conway Flowerree, Colonel of the 7th Virginia Infantry. Colonel Flowerree moved to Vicksburg after the war and became an ice merchant. Note: the ambrotype is on display in the Confederate room. There is also a speech given by Flowerree about his military service in the Flowerree genealogy file.

Lee, Robert E. Photographs and letter, 1870. 3 Items.

Two photographs of General Robert E. Lee, the first a 4 x 8 post-war shot in civilian clothes. A note written on the back says, "*Retouched for the benefit of the memorial church at Lexington vesperies by Mary Custis Lee.*" The second photo is of Lee and two of his staff taken after the surrender at Appomattox. The backmark is M. B. Brady & Company, Washington, D. C. Also included in the file is a copy of a notice sent to Warren County informing the people that Lee had died, dated November 11, 1870. The original notice is in the black book.

Randolph, Thomas J. Photograph, ????. 1 Item.

Pre-war CDV of Thomas J. Randolph, a Sergeant in Company A, 19th Virginia Infantry. Randolph was killed in battle at Boonsboro Gap, Maryland, on September 14, 1862.

Alexander, Joseph. Letter, 1863. 1 Item. *UNIDENTIFIED MISSISSIPPI STATE TROOPS*

Photocopy of a letter written by Confederate soldier Joseph S. Alexander at Jackson, Mississippi, to Lieutenant C. W. McNiell. The letter is dated April 17, 1863, and talks about the possibility of a Union attack on Vicksburg. *3RD BN OR 5TH REGIMENT M.S.T.*

Fuller, Jack. Letter, 1862. 1 Item.

Letter from Jack Fuller in Mayville, Alabama dated January 31, 1862. He is writing to a friend in Vicksburg discussing the war situation. Located in the black book.

Jones, W. H. Letter, 1864. 1 Item.

Letter written by Confederate soldier W. H. Jones to his grandfather Henry W. Jones of Oxford, North Carolina. The letter was written from Canton, Mississippi on January 30, 1864, and talks about the war in Mississippi.

Leavy, John A. Memoir, ????. 1 Item.

Photocopy of a memoir by Confederate soldier John A. Leavy, who was probably a Missourian. Leavy goes into great detail about the battles of Champion Hill, Big Black River, and the siege of Vicksburg.

Sherard, Samuel Wiley. Letter, 1863. 1 Item.

Photocopy of a letter written by Samuel W. Sherard, Captain of Company F, 24th South Carolina Infantry. The letter was written from Canton, Mississippi, on May 28, 1863, and talks about the regiments participation in the battle of Jackson.

Stanford, Mary. Newspaper clipping, ????. 1 Item.

Undated newspaper clipping from the Vicksburg Herald containing a poem written by Mary Stanford to commemorate her son who was killed in the siege of Vicksburg. Located in the Civil War files under General.

Third North Carolina Infantry Reunion Photo. 1902, 1 Item.

Copy of a reunion photograph of the survivors of Company A, 3rd North Carolina Infantry, in 1902.

Watson, John J. Letter, 1863. 2 Items.

Two letters written by John J. Watson, a member of an unidentified Confederate unit, to his parents. The first letter is dated March 5, 1863, and asks about life at home. The second is undated and briefly describes the fighting taking place around the city. Located in the black book.

Adams, Matthew R. Letter, 1863. 1 Item.

Photocopy of a letter written by Orderly Sergeant Matthew R. Adams, a member of Company B, 13th Illinois Infantry. The letter is written to his sister and is dated January 31, 1863 from a camp opposite Vicksburg. In the letter Adams describes the geography of Vicksburg and how difficult it will be to take the town by assault.

Avery, P. O. Memoir, ??????. 1 Item.

Typescript copy of the memoir of P. O. Avery, a member of Company I, 4th Illinois Cavalry. The diary covers the entire war and goes into great detail about the regiments service in the Vicksburg area after the siege. Located in Civil War File Drawer #3.

Baker, William Melville. Letter, 1863. 1 Item.

Photocopy of a letter from Captain William M. Baker, Chaplain of the 97th Illinois Infantry, to his wife Eliza in Springfield, Illinois. The letter was written from Vicksburg and is dated July 28, 1863. In the letter Baker talks about sending home a Ketchum hand grenade and a shell fragment as souvenirs of the siege. Note: the grenade and shell fragment described in the letter are on display in the Confederate room along with a book sent home by Baker to his wife.

Ball, Isaac N. Song, 186-. 1 Item.

Song lyrics written down by Isaac M. Ball, a member of Company E, 14th Illinois Infantry while serving in Mississippi during the Vicksburg campaign. The song is titled, "*Reply to the Bonnie Blue Flag.*" Located in the Blackburn genealogy file.

Barker, Abiel M. Diary, 1863. 1 Item.

Typescript copy of the diary of Abiel M. Barker, a Sergeant in Company C, 32nd Illinois Infantry. The diary goes into considerable detail about Barker's service during the Vicksburg campaign.

Batterton, Ira A. Photographs, 1854-1865. 3 Items.

Copies of photographs of Ira A. Batterton, a member of Company K, 8th Illinois Infantry. The first photo is circa 1854 and shows Batterton with his two sisters. The second is circa 1862 and shows Batterton in uniform. The third is circa 1865 and shows Batterton in civilian dress at the time he was editor of the Vicksburg *Daily Herald*. The file also includes research on Batterton done by his relative M. F. Batterton.

Beck, S. C. Memoir, ??????. 1 Item.

Photocopy of the memoir, A True Sketch of His Army Life by S. C. Beck, a member of Company C, 124th Illinois Infantry. The memoir covers the period from August 11, 1862 – May 12, 1865. Beck goes into great detail about the Vicksburg campaign and includes reminiscences about a trip to Vicksburg in 1908.

Buck, George R. Letter, 1863. 1 Item.

Typescript copy of a letter written by George R. Buck, a Lieutenant in Company K, 17th Illinois Infantry. The letter is dated June 9, 1863 from Vicksburg, and gives an account of the regiments fighting during the siege.

Buckner, Richard M. Memoir, 1899. 2 Items.

Photocopy of a memoir written by Richard M. Buckner, a Private in Company E, 1st Illinois Light Artillery. Buckner was a doctor by profession, and after the siege of Vicksburg ended he was assigned to duty in a hospital established in the Prentiss House Hotel. The file also includes a letter to Buckner written from the Prentiss House on November 4, 1863, thanking the doctor for his good work at the hospital.

Capron, Charles. Letters, 1863-1865. 48 Items.

Letters written by Charles Capron, a member of Company A, 89th Illinois Infantry, to his family. The letters cover the period from October 30, 1863 – July 11, 1865, and describe in great detail the battles of Chickamauga, Chattanooga, Atlanta, and Nashville. Located in the black book.

Churchill, Samuel Joseph. Memoir, ????. 1 Item.

Typescript memoir of Samuel Joseph Churchill, a member of Company G, 2nd Illinois Light Artillery. The memoir covers the period from December 1862 until the end of the war. Churchill was awarded the Medal of Honor for his gallantry at the battle of Nashville.

Hathaway, Jeremiah J. Marriage License, 1863. 1 Item.

Marriage license issued in Vicksburg to Jeremiah J. Hathaway, a member of Company B, 46th Illinois Infantry, to marry Miss Cornelia F. Love. The marriage was performed by William Rutledge, Chaplain of the 14th Illinois Infantry, on December 30, 1863. Located in the black book.

Heath, James Darsie. Diary, 1862-1865. 1 Item.

Typescript copy of the diary of James D. Heath, a member of Company A, 72nd Illinois Infantry. The diary covers the period from August 1862 – April 1865, and details Heath's day-to-day experiences with the regiment.

Ketzle, Henry. Memoir, ????. 1 Item.

Typescript history of the 37th Illinois Infantry by Henry Ketzle who was a member of Company A. The 37th spent most of the war in the Trans-Mississippi Theatre but did take part in the siege of Vicksburg.

CIVIL WAR FILES (U.S. NAVY) PRIMARY SOURCES

Elwell, Zeno P. Letter, 1863. 1 Item.

Photocopy of a letter written by Zeno P. Elwell, a sailor on the *U.S.S. Hartford*, to his friend John Day Jr., of Gloucester, Massachusetts. The letter was probably written in early May, 1863, as Elwell mentions his ship running past the Vicksburg defenses.

Hall, Dr. R.R. Papers, 1862-1863. 5 Items.

Newspaper serialization of the diary of Dr. R.R. Hall, Surgeon on the *U.S.S. Cincinnati*. The diary was published in an unidentified paper from Wichita, Kansas, and covers the period from December 1862 – March 1863. Included in the file are two photographs of Dr. Hall, one taken in 1866, the other many years after the war.

Harvey, D. Letter, 1862. 1 Item.

Photocopy of a letter written by D. Harvey, a sailor serving on board the *U.S.S. Westfeld*. The letter was written June 23, 1862, from near Vicksburg, and complains about how slow Farragut has been in reaching Vicksburg.

Hiatt, George L. Diary, 1863-1865. 1 Item.

Diary of George L. Hiatt, a member of Company K, 1st Mounted Infantry, Mississippi Marine Brigade. Hiatt was assigned to the *U.S.S. Baltic*, and his diary covers the period from May 1863 – April 1865. Hiatt describes his participation in the Vicksburg campaign in great detail.

Voorhies, Ralph. Letters, 1863. 5 Items.

Letters written to Ralph Voorhies, Captain of the steamer *J. C. Swon*, concerning the participation of his ship in the Steele's Bayou expedition. The letters are dated April 1-2, 1863, and were written by the Quartermaster's Department, Transportation Office, on board the steamer *Henry Von Phul*.

Walker, Samuel. Letter, 1863. 1 Item.

Photocopy of a letter written by Samuel Walker, a sailor on the *U.S.S. Kineo*, describing the explosion of the steamer *City of Madison* at Vicksburg on August 18, 1863. Located in the James Warren file. UNDER "City of Madison" File

Albright, John. Letter, 1864. 1 Item.

Typescript copy of a letter written by John Albright, a member of Company K, 16th Wisconsin Infantry. The letter is dated March 26, 1864 from his camp at the Big Black River. Albright was a new recruit to the regiment and he mentions that he hopes he will be able to stand up under fire.

Beardsley, Homer. Letters, 1863-1864. 2 Items.

Photocopies of two letters written by Homer Beardsley, a member of Company D, 33rd Wisconsin Infantry, to his family in Ellsworth, Ohio. The first letter is dated May 8, 1863 at Memphis, and the second January 13, 1864 from Vicksburg.

Britton, William B. Letters, 1863. 10 Items.

Typescript letters of William B. Britton, a member of Company G, 8th Wisconsin Infantry, written to his hometown newspaper in Janesville, Wisconsin. Britton entered the service as Captain of Company G, and eventually became Lt. Colonel of the regiment. Letters pertaining to Vicksburg are dated between February 1863 – July 1863, and have considerable detail about the siege. A complete set of 67 letters written by Britton are available at the Western Reserve Historical Society, Cleveland, Ohio.

Dodge, Henry Judson. Letters, 1863-1864. 2 Items.

Photocopies of two letters written by Henry Judson Dodge, a member of Company K, 33rd Wisconsin Infantry. The first letter is dated August 30, 1863 and describes the aftermath of the Vicksburg siege. The second letter is dated June 12, 1864 from Memphis and describes the Red River campaign.

Duncan, Eugene. Memoir, ????. 1 Item.

Photocopy of a memoir by Eugene Duncan, a member of Company A, 16th Wisconsin Infantry. Duncan gives an account of his service from 1861 – 1865, and also talks about a bell that some of his fellow soldiers stole from Jefferson Davis' plantation and sent back to Wisconsin. Located in the Brierfield Bell subject file.

Eastman, Henry S. Letter, 1863. 1 Item.

Photocopy of a letter written by Henry S. Eastman, Major of the 2nd Wisconsin Cavalry to a Mr. Hyland of Vicksburg. The letter is dated November 23, 1863, and proposes a meeting to discuss business. The file also contains a brief synopsis of Eastman's military service.

Grigsby, Melvin. Memoir, 1888. 1 Item.

Photocopy of an extract from the memoir of Melvin Grigsby entitled, The Smoked Yank. Grigsby was in Company C, 2nd Wisconsin Cavalry, and relates his capture in 1864 by Whitaker's Scouts while on a cotton stealing expedition.

Hodgson, Thomas R. Diary, 1862-1863. 1 Item.

Typescript copy of the diary of Thomas R. Hodgson, a member of Company A, 33rd Wisconsin Infantry. The diary covers the period from August 1862 – June 1863. Hodgson died June 28, 1863 of typhoid and is buried in the National Cemetery at Vicksburg. Included with the diary is a photograph of Hodgson in uniform. Located in Civil War File #3.

Kenyon, Byron. Letters, 1861-1862. 5 Items.

Photocopies of five letters written by Bryon Kenyon, a member of the 4th Wisconsin Infantry/Cavalry. Four of the letters were written during the 1862 Vicksburg campaign.

Mattice, Oscar F. Letter, 1863. 1 Item.

Photocopy of a letter written by Oscar Mattice, Captain of Company A, 29th Wisconsin Infantry. The letter is dated May 24, 1863 and describes the fighting at Champion Hill and Vicksburg. Written on the envelope of the letter is the message "*Captured at Champion Hills, Miss. May 16, 1863.*"

Payne, Emmet C. Letter and Poem, 1864. 2 Items.

Photocopy of a letter written by Private William Payne, a member of Company E, 2nd Wisconsin Cavalry. The letter was written March 27, 1864, while the regiment was stationed at Redbone Church south of Vicksburg. Payne was killed in a skirmish at Redbone on April 21, 1864. The file also includes a photo of Payne in uniform and a poem written by one of his comrades about his death.

Roesch, Phillip. Diary, 1862-1865. 1 Item.

Typescript diary of Phillip Roesch, a member of Company H, 25th Wisconsin Infantry. The diary covers the period from August 1862 – June 1865, and goes into great detail about the Atlanta campaign.

Thompson, Archibald. Diary, 1863. 1 Item.

Photocopy of the diary of Archibald Thompson, Commissary Sergeant of the 8th Wisconsin Infantry. The diary covers the period from March – April 1863, and most entries are concerned with Thompson's commissary duties. Thompson died of typhoid May 19, 1863 at Grand Gulf, Mississippi. Included in the file is a photograph of Thompson in uniform.

West, Emmet C. Memoir, ????. 1 Item.

1982 reprint of History and Reminiscences of the Second Wisconsin Cavalry Regiment by Emmet C. West, a Quartermaster Sergeant of Company E.

Banks, Nathaniel. Telegrams, 1862. 4 Items.

Four telegrams sent to General Nathaniel Banks between June 2 – June 14, 1862. Located in the black book.

Bowman, Fletcher. Letters, 1861-1862. 5 Items.

One letter and four photocopied letters written by Fletcher Bowman, member of a U. S. Infantry regiment, possibly the 8th Kentucky Infantry. The letters are dated between November 9, 1861 – May 10, 1862.

District of Mississippi Orders, 1863. 1 Item.

Special orders from the Headquarters of the Western District of Mississippi dated December 6, 1863 at Vicksburg. The orders relate to the building of barracks for the 49th U. S. Colored Infantry and the 5th U. S. Colored Heavy Artillery. Located in the black book.

Fore, Thomas. Court Martial, 1865. 1 Item.

Photocopy of the court martial records of Thomas Fore, a member of Company D, 52nd U. S. Colored Infantry. Fore was one of the men accused of the murder of Minerva Cook, a native of Warren County, Mississippi.

Gregory, A. Letter, 1863. 1 Item.

Letter from Union soldier A. Gregory to his wife dated June 7, 1863 from Haynes Bluff describing life in camp. Located in the black book.

Gregory, Charles S. Letter, 1863. 1 Item.

Letter written by Charles S. Gregory, a Union soldier and brother of A. Gregory listed above. The letter was written in July 1863 and is located in the black book.

Knox, Ira Kilborn. Letters, 1863-1866. 2 Items.

Photocopies of two letters written by Ira Kilborn Knox, Captain in the 13th U. S. Infantry and attached to General James B. McPherson's staff. The first letter is dated May 9, 1866 and is a synopsis of Knox's war record submitted to the U. S. Army promotion board.

Mason, John Edwin. Article, ?????. 1 Item.

Typescript copy of an article written by John E. Mason entitled, "*A Masonic Carnival of the Battlefield*," published in the Masonic Monthly, dated unknown. Mason was an Ordnance Officer in the 9th Army Corps.

McDowell, Irvin. Telegram, 186?. 1 Item.

Undated telegram sent by General Irvin McDowell. Located in the black book.

Bates, Henry C. - USS. Silver Cloud 1864

Sanborne, Pliny Fiske. Diary, 1864. 1 Item.

Typescript diary of Pliny Fiske Sanborne, Chaplain for an unidentified Union regiment that served in the east. The diary covers the period from June 1864 – August 1864.

Sellers, Henry. Letter, 1865. 1 Item.

Letter written by Henry Sellers, a member of Company H, 21st Connecticut Infantry. The letter was written from a camp near Washington at the end of the war and describes life as a new soldier.
